

FEE NOTES

DEVELOPMENT FUND LEVY (Taxable at 20%)

A Development Fund Levy of 5% of the full fee is added to the fees invoice. This levy assists the school to invest in ongoing developments, to ensure that we offer young people the very best learning environment at all times. Rather than include the levy in the fees, we separate out to ensure that these funds are used for infrastructure and developments only.

NURSERY FEES (Exempt from VAT)

Generous loyalty discount of up to 50% is available for fees in Reception, Years 1 and 2 for nursery pupils who attend at least two terms and is based on the number of weekly paid sessions attended in nursery. The discount is reviewed annually.

6TH FORM FEES (Taxable at 20%)

Generous loyalty discount of up to 50% are available for fees in 6th Form based on the number of years a pupil has attended in the school. The discount is reviewed annually.

PERSONAL ACCIDENT INSURANCE (Exempt from VAT)

Obligatory Personal Accident Insurance of £13.38 per pupil per term is added to fee invoice.

SCHOOL FEES REFUND SCHEME (Exempt from VAT)

If a child is absent from school due to long term illness, injury or any other cause, the school cannot refund fees for the period missed. The fees refund scheme provides cover for a refund of fees in such instances. The charge for this is 1.34% of school fees and you need to opt into this by contacting finance@gosfieldschool.org.uk.

TRIPS AND VISITS (Exempt from VAT)

Costs of additional trips and visits will be communicated in advance to parents.

EXAMINATION FEES (Exempt from VAT)

GCSE & A Level examination entry and associated fees will be invoiced to parents on receipt from the examination board.

BREAKFAST CLUB (Exempt from VAT)

LATE CLUB (Exempt from VAT)

Designed for families who need the flexibility of a later collection time, our Late Club is for all pupils from Reception upwards and is based in Meadow Court. There is supervised play alternatively homework can be undertaken. A light tea is provided.

Cost is £12.50 per session, from 4.50 pm to 6.00 pm, Monday to Thursday and £17.50 per session, from 3.50 pm to 6.00 pm, on Fridays. Collection is from Meadow Court, Main Reception. A late collection charge of £15 per 15 minutes per child will apply after 6 pm.
